AGENDA ITEM (ACTION ITEM):

Consider/Approve: Armed Security Coverage for the 2018-2019 School Year.

APPLICABLE BOARD POLICY:

09.4361 Students

HISTORY/BACKGROUND:

District Staff have been collaborating with local police jurisdictions and municipal administrations to provide School Resource Officer coverage for all school locations. At this time, there are four (4) schools not covered through the School Resource Officer program managed by local law enforcement. Each of these schools will be covered with armed security guards from Security Solutions of America. The proposal from Security Solutions of America is \$28.35 per hour for each officer.

District staff are still pursuing possible arrangements through local law enforcement departments to provide School Resource coverage. The coverage offered through Security Solutions of America will be discontinued if other arrangements can be established with local government.

FISCAL/BUDGETARY IMPACT:

It is estimated that the annual cost per school to be \$37,000.00 to \$44,000.00 depending upon actual days and hours worked.

RECOMMENDATION:

It is recommended that the Board approve the proposal received from Security Solutions of America for armed security coverage for the 2018 – 2019 School Year.
