## D. Instructional Supervisors' Report

Instructional Supervisor Johnny Belcher shared that state assessment waivers by the U.S. Department of Education would not be granted for the 2020-2021 school year. Mr. Belcher further explained that state assessments would be shortened in number of items and accountability would likely be waived with public reporting happening next fall in some form.

She further explained that PHS would complete a similar review when we return from Spring Break.

Superintendent David Trimble shared complimentary remarks of staff as the district planned to transition to a green schedule remarking that when we return to green schedule it will have been 355 days since all students were in the building together. Mr. Trimble shared additional details about ESSER II funding, ways to involve stakeholders in planning and potential priorities for spending.
