AGENDA ITEM (ACTION ITEM):

Consider/Approve approving the fundraising/advertising agreement with One Holland for a new scoreboard at Simon Kenton High School Football/Soccer Stadium.

HISTORY/BACKGROUND:

In accordance with KRS 45A.097 The Kenton County School District requested approval from the Finance Cabinet to advertise for the Simon Kenton Scoreboard Project. The email request was sent on Wednesday, August 8, 2018, at 4:14 pm est. Per KRS 45A.097 after a twenty-four (24) hour waiting period with no response The Kenton County School District was permitted to advertise the project on the District's Website. No response was received from the Finance Cabinet on or after the twenty-four (24) hour waiting period therefore The Kenton County School District posted an advertisement on the KCSD Website at 4:27 pm on August 9, 2018, soliciting sealed bids for the project due on August 17, 2018 at 10:00 am.

Bids were opened and read at 11:03 am on August 17, 2018. Only one bid was received. This bid was from One Holland Group to fully fund the Simon Kenton High School Football/Soccer Stadium Scoreboard Project in the approximate amount of \$200,000.00. This agreement is for a length of seven (7) years beginning on January 1, 2018 and ending on December 31, 2025. One Holland will receive at least 50% of the advertising time allowed on the video board during all events held at the Simon Kenton Stadium. No other food or restaurant advertising (except those approved by One Holland) will be allowed on the video scoreboard or A-frame panels. LaRosa's will be the only pizza sold at the Simon Kenton outdoor stadium concessions. Skyline will be the only chili sold at the Simon Kenton outdoor stadium.

It is recommended that the Board award the bid to One Holland for the purchase and installation of a new scoreboard for the Simon Kenton Stadium.
