Consider/Approve: Change Order No. 04 – Morel Construction – Scott High School Phase IV – BG 18-038

## <u>APPLICABLE BOARD POLICY</u>: Capital Construction Process – 702 KAR 4:160

#### **HISTORY/BACKGROUND**:

This is the fourth change order of the Scott High School – Phase IV project associated with Morel Construction Company. The original contract with Scott High School Phase IV is \$7,425,581.00. This change order for an additional \$7,378.00 with previous change orders of \$79,088.00 makes the new contract sum \$7,512,047.00.

Item # 1 – Delete overhead coiling doors, replace with pairs of oversized swing doors, replace basement door and frame. ADD: \$1,169.00

Item #2 – Add CT cabinet and conduit to new fire pump in addition to meter base.

ADD: <u>\$6,209.00</u> TOTAL: <u>\$7,378.00</u>
