

This is an agreement between the Florence Freedom (VENUE) and the Simon Kenton High School baseball team (VENDOR) for the High School Showcase held April 18, 2019 at UC Health Stadium in Florence, Kentucky.

By signing this agreement, the VENDOR agrees to the following:

1. Play on Thursday, April 18 at 5:00pm against Milford High School in a regulation high school baseball game governed by KHSAA rules.
2. Supply own baseballs for pre-game warmup, bats for game use and catchers gear for the game.

The VENUE agrees to supply the following for the vendor:

1. Pay each team playing in the showcase an appearance fee of \$200.
2. Supply baseballs to be used for the game.
3. Cover the costs of the umpires.
4. We will run the video board, PA & scoreboard to make these as much like an actual Freedom game as possible.
5. Make it a prerequisite that a coach on their college staff's that are playing games at UC Health Stadium in the spring be present for each of the showcase nights.
6. Create a traveling trophy awarded to the state that wins the most games head to head.

Other info:

1. The venue will operate a gate of \$5 for students and \$7 for adults. Each admission will cover all games played on that day at UC Health Stadium should a game come before or after your scheduled game.
