SUMMARY OF ISSUE BEFORE THE BOARD:

To take action on the repeal of 701 KAR 5:080, *Application for approval of alternative school-based decision making model*. The application process has been incorporated into 701 KAR 5:100.

COMMISSIONER'S RECOMMENDATION:

The Commissioner recommends approval on the repeal of 701 KAR 5:080, *Application for approval of alternative school-based decision making model*.

APPLICABLE STATUTE OR REGULATION:

KRS 160.345 701 KAR 5:100

BACKGROUND:

Existing Policy:

KRS 160.345 establishes a statutory administrative structure for school-based decision making (SBDM) councils but allows for schools to apply for exemption from the statutory model through application to the Kentucky Board of Education (KBE).

This administrative regulation repeals 701 KAR 5:080, *Application for approval of alternative school-based decision making model*, because the required application that must be submitted to the KBE to receive an exemption from the statutory administrative structure for school councils and have an alternative SBDM model approved is being incorporated into 701 KAR 5:100, as amended.

Summary of Issue:

This administrative regulation repeals 701 KAR 5:080, *Application for approval of alternative school-based decision making model*, because the required application that must be submitted to the KBE to receive an exemption from the statutory administrative structure for school councils and have an alternative SBDM model approved is being incorporated into 701 KAR 5:100, as amended.

Budget Impact:


The repeal of 701 KAR 5:080 has no fiscal impact on state or federal funds.
