At the May 23, 2016 Bullitt County School Board meeting, the Bullitt County School Superintendent was given the authority to approve a construction Change Order up to \$7,500.00 in cases to keep the project moving without delay. At this time, I am asking for approval for Change Order #1. The total for this Change Order is an add of \$3,373.15 and will cover the primary electric with concrete underground from Golden Wing Road to the transformer at the loading dock.

Although Salt River Electric does not require the lines to be encased in concrete, due to safety reasons, the Bullitt County Maintenance Department has asked for this request to completely encase the electrical lines in concrete. Change Order Description And Justification

BCPS's lead electrician reviewed design drawings on site related to questions on site electrical lines being encased in concrete versus a heavy duty conduit below grade. Their preference was to omit concrete encasement for communication lines and electrical with lesser volatage and completely encase the primary electrical lines (the line that runs for the utility connection to the building transformer). The resulting trade in scope resulted in a cost add due to the primary line requiring a larger concrete duct back based on line size and number. The base bid documents showed the primary line at 48-inches deep with a tracer wire that allows the utility company to locate lines below grade. BCPS noted this design was acceptible, however, in terms of ongoing facility maintenace and crew safety, concrete encasement garuntees that lines would not be encountered accidentaly through digging.

Cost Benefit To Owner

Revision of scope can be performed by trades already contracted and mobilized on site ahead of parking lot and driveway asphalt work.


