CONSENT AGENDA ITEM: Request approval of agreement for Apex Learning, a digital learning curriculum, to be utilized by students at various schools in Floyd County.

APPLICABLE SATUE(S), REGULATIONS OR BOARD POLICY: 160.345

FISCAL/BUDGETARY IMPACT: The discounted cost to the district will be \$167,490.75 beginning July 2021 to July 2024. The fund source will be ESSER (The Elementary and Secondary Emergency Relief Fund). This cost includes High School Courses with unlimited enrollments for all students districtwide and also an unlimited subscription to Apex Tutorials that can be utilized beginning with grade six. The district will receive three days per year of onsite Professional Services. The contract is subject to renewal as long as the schools continue to utilize the software programs.

HISTORY/BACKGROUND: Floyd County schools are committed to providing individualized instruction to meet the needs of all students. Apex Learning has paid close attention to how students learn and how digital curriculum can personalize learning to better meet the needs of all students and to increase academic performance. Recent examples of their unwavering commitment to innovation include their new generation of courses, expanded offerings for middle school, and targeted focus on pathways of study to support CTE programming.

RECOMMENDATION ACTION: Approve contract agreement between Floyd County Public Schools and Apex Learning.
