Floyd County Board Of Education Issue Paper

Date: April 5, 2021

<u>Action/Discussion Item:</u> Approve an agreement between the Floyd County Board of Education and Academic Edge for the purpose of providing Floyd County Schools with the supplemental Reading Programs: Lexia (K-8) and Reading Plus (9-12), for August 2021 – July 2024.

<u>Applicable Statutes or Regulation:</u> Board Policy states that only the Board of Education may enter into contracts and agreements.

Issue/Background: The Floyd County School District utilized Lexia and Reading Plus districtwide during the 2020-21 School Year with much success. This online supplemental reading program allows students to work both independently and within groups to develop critical reading and language skills. Each lesson provides data for students, teachers and parents and helps develop future lessons and reading standards. This embedded data disaggregation allows for students to be assessed individually without testing. Each student will be placed within their own individualized learning path that will motivate students to improve reading skills within the program. Reading Plus is geared to meet the needs of high school students. High School students will work on reading comprehension, vocabulary, self-efficacy and silent reading efficiency. Improvement related to these skills will help students as they take assessments such as the ACT or work toward meeting career pathway goals before and after graduation.

Budget/Financial Issues: The cost of \$246,024.00 will be paid from ESSER Funds. This price contains a multi-year discount and will be available to all students in all Floyd County Schools.

<u>Recommended Action:</u> Approve the agreement between the Floyd County Board of Education and Academic Edge for the purchase of the supplemental reading programs (Lexia and Reading Plus) from August 2021 to July 2024.
