AGENDA ITEM (ACTION ITEM):

Consider/Approve Supplemental funding from the Board to the High and Middle Schools for revenue lost due to COVID-19 attendance limitations at 2020-21 Fall and Winter athletic events. Schools will receive 80% total lost revenue based on gate receipts from prior 2 year average.

01.1 Legal Status of the Board

HISTORY/BACKGROUND:

In order to host athletic events and adhere to the Governor's Healthy at Work and KHSAA guidance each school limited the number of patrons that could attend games. The limited attendance had a negative impact on athletic revenue generated. This revenue helps fund every athletic team at each school.

FISCAL/BUDGETARY IMPACT:

Each school will receive 80% of lost revenue based on gate receipts from prior 2 year average.
