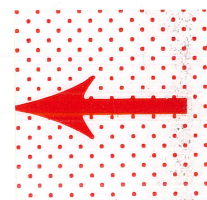
Prices include labor for set up and tear down. You are only charged for what we set. We will add 6% Ky. Sales tax to all materials unless provided with tax exempt form.
