1. Opening Business

- a. <u>Welcome</u> Ms. Nickell welcomed everyone to the SBDM meeting.

- d. <u>Good News-</u> All students are back in the building for 5 days of instruction!! We are doing the one way hallways, 3 feet pods, staggered releases between classes, lunch facing the same way & ½ of the students are eating in the cafeteria and ½ in the classroom, teachers / custodian are cleaning every period, mask breaks have been reduced & taken as needed and the students also can take a break outside during transition.

Both 7th and 8th grade volleyball teams are headed to the tournament this week, Archery has been able to compete in tournaments, STLP teams (would like to show us their project), EHMS had our last home game here at the Brent Wagoner gymnasium and honored all the former athletes with a slideshow of memories, Academic Team competed at the state level this month and are waiting to hear results.

- 2. <u>Planning:</u>
 - a. <u>Monthly Review</u> 3rd quarter PBIS soda and snack, Virtual- 3rd quarter team pride rally recorded and shown to all students on March 22nd, March Madness continues to go well (grade recovery) Monday-Thursday we have a different group of students each day that are able to participate and stay after school to complete missing work.
