Executive Summary

Objective

The objective of this proposal is to outline services in a contract between NaviGo College and Career Prep Services (a division of Learning Grove) and Boone County Schools. The terms of the contract are for the remainder of the 2020-21 school year, as well as the 2021-2022 school year. NaviGo is the service provider of training, support, and *YouScience* implementation.

Goals

The goal of the contract is for Boone County Schools to enhance college and career readiness for all high school students by encouraging students to explore their aptitudes in addition to their interests. Positive, encouraging messaging outlining and highlighting students' natural talents provides a wider scope of career options beyond high school.

Solutions

NaviGo proposes to provide training and ongoing support as high schools in the Boone County district onboard *YouScience*. The aptitude assessment encourages students to discover new careers and serves as a baseline for the district's internally developed Individual Learning Plan (ILP).

NaviGo Services Defined

NaviGo will provide the following services to Boone County High School, Conner High School, Randall K. Cooper High School and Larry A. Ryle High School:

- Provide training and support for administrators to plan for February-March implementation of *YouScience* assessment tool, school-wide.
- Provide multiple training opportunities for faculty and staff (virtual and/or in person) on all levels of *YouScience* assessment and its benefits for students.
- Develop communication plan including social media posts and letters to parents to promote benefits of *YouScience*.
- Facilitate the student *YouScience* implementation, school wide.
- Provide weekly and ongoing support as students are onboarded onto platform.
- Provide annual *YouScience* maintenance with training of new personnel and students, as well as implementation for new incoming class, and full access with annual reporting.

In addition, NaviGo will provide the following services to College & Career Resource Coaches (CCRC) from Boone County High School, Connor High School, Larry A. Ryle High School, and Randall K. Cooper High School:

- Regularly attend CCRC meetings for continued support and troubleshooting
- Train to implement *YouScience* in each school.
- Upload CSV files for all high schools' YouScience activation and engagement reports
