**RE: PRIME DATE REQUIREMENT - REPORT**

At your direction, I have completed the review of the member school’s girls’ basketball schedules.

As per your directive earlier this school year presented to the Board of Control in their July 2020 meeting, there will not be penalties for the 2020-21 season. This year, we notified all KHSAA member schools on March 11, 2021, of their status at the end of the season as an additional reminder.

Each school was notified so they can plan accordingly for future years, particularly 2021-2022. I found 55 schools to be out of compliance with the Board’s 40% prime date requirement during this review. This number is down from the February 16 check of schools in noncompliance (67 schools).

To help prevent issues in the future, the KHSAA office will send a reminder notice to girls’ basketball Athletic Directors and Head Coaches about the Prime Date Requirement for 2021-2022 in the late summer and again in early November. We will then resume the regular monitoring of the requirement for the 2021-22 school year.

The 55 member schools who were out of compliance are as follows:
