BALLYSHANNON MIDDLE SCHOOL (BG #15-279 / REH #129-1214-A)

The project has been backchecked and currently awaits the contractor to submit the final request for payment and accompanying lien releases. Once the final Application for Payment has been certified, the BG-4 and BG-5 Contract and Project Closeout forms will be presented for approval at a future meeting.

RISE ACADEMY (ACE) - RENOVATIONS (BG #21-131 / #129-1020-A)

We continue to meet with Graybach on-site on a weekly basis and detailed phasing plans have been coordinated. The major goal is to get one of the restrooms renovated and the elevator shaft installed prior to the start of school. At that point, the contractor will have a good plan for working around student activities as the remainder of the renovations are completed.

BOONE COUNTY HIGH SCHOOL - ADDITION AND RENOVATIONS (BG #20-183 / REH #129-120-A)

Graybach continues to make good progress and weekly progress meetings continue to be held on-site. The interior renovations are on track to convert the old auditorium into new multi-use classrooms and are scheduled to be complete two weeks before the start of school. They continue to make good progress on the new auditorium – the masonry is pretty much topped out at this point and joists and decking will begin shortly.

BOONE COUNTY SCHOOLS - GEOTHERMAL UPGRADES - PHASE 2 (COOPER, LONGBRANCH, BURLINGTON) (BG #21-128 / #129-1020-C)

Project has been awarded to Hudson Piping, contracts are in process, and the contractor has mobilized with shop drawing submittals in process. Construction activities are to commence after the last day for school for completion by August 1.

BOONE COUNTY SCHOOLS - LED UPGRADES (BOONE COUNTY, COOPER, RYLE, MANN) (BG #21-129 / #129-1020-B)

Project has been awarded to Seco Electric, contracts are in process, and the contractor has mobilized with shop drawing submittals in process. Construction activities are to commence after the last day for school for completion by August 1.

BOONE COUNTY SCHOOLS - PAVING IMPROVEMENTS 2021 (BG #21-201 / REH #129-1220-B)

Three bids were received and opened on April 20. The revised BG-1 and recommendation for award to Riegler Blacktop are being presented for approval at this month's board meeting.

BOONE COUNTY SCHOOLS - PLUMBING UPGRADES (BOONE COUNTY, JONES, BURLINGTON) (BG #21-130 / #129-1020-E)

Project has been awarded to Elite Mechanical Services, contracts are in process, and the contractor has mobilized with shop drawing submittals in process. Construction activities are to commence after the last day for school for completion by August 1.

BOONE COUNTY SCHOOLS - TURF FIELDS (BG #20-184 / REH #129-120-B)

OHeil and Motz continue to make good progress. Ryle High's turf is complete with the rubber track surface going down sometime in June. Boone County High's turf is also complete with the rubber track surface also going down sometime in June. The turf at Conner High has been laid and the infill is currently in process – this turf field will be completed sometime in the next couple weeks. At that point it will take approximately two additional weeks, about June 1, until the contractor can rebuild the track asphalt and the rubber coating will take place in June, similar to the other two projects. The contractor continues to spread the washed drainage material at Cooper High – Motz is scheduled to begin the turf field operation on May 17 and should take approximately one month to complete.

ERPENBECK ELEMENTARY SCHOOL - ROOFING (BG #21-165 / REH #129-1220-A)

One bid was received and opened on April 20. The revised BG-1 and recommendation for award to ACE Exteriors Roofing are being presented for approval at this month's board meeting.

JONES MIDDLE SCHOOL - ADDITION AND RENOVATIONS (BG #21-202 / REH #129-121-B)

The initial BG-1 is being presented for approval at this month's meeting. The drawings are being developed and loose ends are being picked up throughout the building as part of the scope of this project – we are still in the early design phase of gathering initial information regarding site work, the existing structure, and the new construction. It is the intent to submit Schematic Design documents at the June board meeting.
