- Provide meals in: x bulk or unitized
- Prepare meals for: _____ pick up by center or ___x___ delivery by School District Food Service at the time(s) indicated above.
- Provide delivery slips using the KY CACFP delivery slip form or equivalent.
- Submit billing invoice for payment by the _____5th_____ of each month to mailing address provided by center.
- Maintain receipts and cost determination records for a period of 3 years after the end of the agreement period to which they pertain. These records will be made available to the KY CACFP, representatives of the U.S. Department of Agriculture, the child care center and The Kentucky Office of the Inspector General.

The Sponsor/Institution agrees to pay for meals based on the above unit price(s) within 30 days of receipt of invoice. The Kenton County School District Food Service warrants meals provided are safe and wholesome, but that any liability is severed upon receipt

meals. If for any reason, this agreement is no longer desired, either party may terminate these services with a 30 day notification.
