Floyd County Board Of Education **Issue Paper**

Date: May 13, 2021

Action/Discussion Item: Approve an agreement between the Floyd County Board of Education and Great Minds to provide English Language Arts curriculum, teacher and student resources as well as digital resources (3 years) for all students Grades K-8.

Applicable Statutes or Regulation: Board Policy states that only the Board of Education may enter into contracts and agreements.

Issue/Background: The Floyd County School District is developing a systemic curriculum for English/Language Arts. District staff as well as school administrators and teachers met with Great Minds and reviewed the available text, materials and other resources. The team unanimously agreed that the available materials associated with Great Minds, will benefit teaching and learning tremendously.

Budget/Financial Issues: The cost of \$603,897.08 will be paid from ESSER Funds. This price contains a multi-year discount and will be available to all students in all Floyd County Schools.

Recommended Action: Approve the agreement between the Floyd County Board of Education and Great Minds.


