Insurance Renewal

Currently, Assured Partners NL LLC holds the Commercial Property, Commercial General Liability, Commercial Automobile, and Commercial Umbrella insurance plans through Liberty Mutual Insurance. The current year premiums are \$793,992. The renewal quote is \$880,690. This represents a net increase of \$86,698. While this is an increase, this is a good renewal with the uncertainty in the marketplace right now. A comparison of current year to renewal year is provided.

I ask the Board to approve renewal for insurance plans with Assured Partners NL LLC through Liberty Mutual Insurance. Next year, our Insurance Agent of Record will bid our insurance services.
