Comes the Petitioner with just cause in filing this Open Meetings complaint against the Spencer County School Board for violating the Kentucky Open Meetings Act.

Petitioner asserts that he has personally witnessed and documented the use of personal cell phones being used during Spencer County School Board "Special Meeting" and Regular meeting gatherings to include Executive Session portions by school board members. Petitioner cites the meeting dates of April 25, 2021 and April 26, 2021 as examples.

The above stated actions create an environment that is concerning and distressing, in that, the public has no way to ascertain nor confirm that the use of the cell phones is not being used to conduct "POLLING" activities or conversing with other members of the school board and or the superintendent, while public discussions of business is being performed during school board meeting operations. The cell phones are personal, not board provided.

Petitioner seeks relief in the following forms:

- 1.) Cease and desist using cell phones by school board members and the superintendent during "SPECIAL meetings", Regular meetings and Executive Sessions.
- 2.) Publicly acknowledge that cell phones have been used in the past improperly and affirm to the public, that such action will not be engaged in, in the future.



Dear Counselor Chenoweth, et.al

I am requesting the following information:

1. Any and all complaints directed to the Board of Education about Chuck Adams that I can incorporate into all matters presented by me with particularity therein. If this is confusing, I want information that I can use to verify that Mr. Adams is capable of manipulating laws, policy and procedure for his personal gain and to my detriment.
2. The personnel file of Charles Adams. I understand there are limitations and redactions that are necessary.
3. The personnel files of Grant and Bob Chenoweth along with policies and procedures regarding the official job description and responsibilities of a school board attorney. I need to know about any potential conflict of interest you might have in providing me with requested information so that I can request it by other means if I need to. I understand there are limitations and redactions that are necessary.
4. The personnel file of Principal Curt Haun. I understand there are limitations and redactions that are necessary.
5. Any and all complaints directed to the Board of Education or Chuck Adams about Curt Haun that I can incorporate into all matters presented by me with particularity therein.
6. All complaints written by parents, citizens, and employees of Spencer County about other employees during Mr. Adams tenure as a Superintendent and the action taken if I can get that. Particularly, several citizens have told me that they complained about some teachers getting political in their classrooms and discriminating against students for holding to a particular political position. I need whatever information you can provide on that. I understand there are limitations and redactions that are necessary.
7. The personnel records of Leighann Day, Rose Nash, Amber Martin, Sean McClelland, John Davidson, Greg Taylor, Tammy Hawkins, Mary Baldock, and Dorothy Beaverson. I need to know if policy and procedure was estopped to the benefit of these teachers. If there is nothing there, so state. I understand there are limitations and redactions that are necessary.
8. I need the emails and text messages that were written to Mr. Adams about me.
9. I need a follow-up from the information you gave me that suggested I was being investigated for being a disruption of the education process because of my "mental state." I need information about the decisions made to not have me placed on leave of absence from the time it was allegedly reported that I was suffering from some sort of "mental state" to the end of the 2018 academic year (re: the emails that Ms. Stevens and Ms. Clemens wrote complaining about not feeling safe by having me in the building). I need any documentation that mentions what sort of interventions were taken to ensure the safety of Ms. Clemens, Ms. Stevens, and the well-being of myself. I need any documentation that mentions what sort of action was taken to remedy the problem of me being a disruption to the education process that I could have corrected had this information been duly processed.
10. I need information from SITE BASED and others about the approval of Amber Martin's "Faculty Wall of Fame" project. Particularly (not limited to), back towards the end of the 2017-2018 school year, Ms. Martin emailed all faculty and staff at the high school about how to submit votes for the "Faculty Hall of Fame Member of the Year." She indicated in the email that she took the votes home with her to tally them there. And then after tallying the votes she took home with her, she emerged as the winner. With this, it should be obvious why I

need this information. Also, if you could, please have Ms. Martin turn over the positive comments made about me by students in support of me elected to the Faculty Wall of Fame. Furthermore regarding Amber Martin, I need to know if there were any complaints launched against her for her relationship with a student with the initials Z.F. and if so, I need the details of those complaints. Ms. Martin was witnessed by me and others wearing a soccer jersey with the last name "Fawbush" on it. This was the last name of a student she was witnessed being alone with behind closed doors. This activity was the subject of concern among teachers, as well as the subject of gossip among teachers at the time and relevant to my case because I had complained to Mr. Haun about Ms. Martin making inappropriate/unprofessional statements about me.

THIS JUST IN!!!

The time is 3:10 p.m. on Monday April 14<sup>th</sup> and I just received a disturbing phone call from a citizen of Taylorsville. Apparently Mr. Chuck Adams is being complained against for inappropriate communications with another teacher, reports of abuse against his spouse, and further attempts to estop laws, policies, and procedures to his benefit. So, I am going to be needing information on that as well.

Please keep the lines of communication open regarding these requests. I made a similar request to the Board's other attorneys, the ones who are litigating against me, but received no response. I am willing to turn over everything related to my case and would appreciate they do the same. I know you will forward this to them, and that is okay. I am all in favor of being transparent. I believe justice is impossible without transparency.
