SUMMARY OF ISSUE BEFORE THE BOARD:

To review the first draft of the new strategic dashboard and to provide on update on establishing the Kentucky Coalition for Advancing Education and the coalition's working moving forward.

APPLICABLE STATUTE OR REGULATION:

Elementary and Secondary Education Act; KRS 156.029(7); KRS 156.070; KRS 156.148

BACKGROUND:

Existing Policy: State law provides that the Kentucky Board of Education (KBE) shall select a Commissioner of Education who is responsible for administering, structuring and organizing the Kentucky Department of Education. Additionally, the KBE also requires the Commissioner to establish goals, which he will be evaluated on annually.

Summary of Issue: In order to develop a new strategic plan, Commissioner Glass requested a statewide survey to gather feedback from stakeholders regarding what the KDE and educators in Kentucky should keep doing, stop doing and start doing. Survey results have been shared with the board. Additionally, one of the Commissioner's goals is to provide transparent reporting of pre-K-20 indicators and long-range goals related to student outcomes, the educator workforce (including the diversity of the teacher workforce) and student engagement, benchmarked against other states as measured by the establishment of goals, benchmarks and the development of a strategic dashboard. Proposed metrics for this dashboard have been reviewed by the board. The dashboard is currently under development by KYSTATS and will be reviewed. A coalition is being formed to analyze all the input gathered. Discuss the process used to form the coalition and the objective of the coalition.

Budget Impact: Costs for implementing the strategic plan impact state funds and occur at the initiative level. There is no cost for working with KYSTATS.

GROUPS CONSULTED AND BRIEF SUMMARY OF RESPONSES:

The metrics for the dashboard have been shared with the KDE leadership team with general approval. We can share with advisory groups when a complete mockup is ready.
