AGENDA ITEM (ACTION ITEM):

Consider/Approve the purchase of a three year agreement with CERT (College Equipped Readiness Tool) for 9th, 10th, and 11th grade high school students for the 2021-2022, 2022-2023, and 2023-2024 school year.

APPLICABLE BOARD POLICY:

1.11 General Powers of the Board

HISTORY/BACKGROUND:

CERT is an ACT College and Career Readiness diagnostic tool that is a part of the KCS D balanced assessment approach. It is used to measure student proficiency towards ACT Standards in English, Mathematics, Reading, and Science, including whole ACT practice tests. All CERT tests match the format (i.e., # of questions, question types, difficulty level, timing, etc.) of the current ACT. Through triangulation with other data sets, it helps to guide instruction, provide for differentiation, and identifies targeted supports for individual and small groupings of students. Through purchasing a three year agreement with CERT, it is a total savings of \$9,900.00 for grades 9, 10, and 11.

FISCAL/BUDGETARY IMPACT:

\$101,700.00 from ARP ESSER Funds (TBD)


