Pursuant to KRS 157.655-157.660 and 750 KAR 2:010, the School Facilities Construction Commission has made an official KY-2021 KETS Offer of Assistance. Acceptance of this Offer of Assistance commits the District to follow the statues and regulations of the SFCC and the Kentucky Department of Education governing the Education Technology Funding Program. Based upon the final FY-2020 statewide ADA figures, the Third Offer of Assistance in FY-2021 is in the amount of \$83,015.00. Acceptance of the state technology fund Offers of Assistance must be matched equally by the District or can be escrowed for up to (3) years.
