APPLICABLE BOARD POLICY:

01.1 Legal Status of the Board

HISTORY/BACKGROUND:

Conscious Discipline is an evidence-based, trauma-informed approach. The Board approved the Conscious Discipline Agreement to provide professional development and coaching for the 20-21 school year. Due to limitations based on pandemic guidelines, activities will carry over into the 21-22 school year. Adjustments have been made to virtual and in person sessions staying within COVID guidelines.

FISCAL/BUDGETARY IMPACT:

Original contract \$55,340 Amendment reduces contract to \$24,810 CCEIS Special Ed, \$11,000 CECC Grant Funding & \$12,000 Early Childhood Healthy Living Grant

Approval to amend the Conscious Discipline Agreement as reflected in the Amendment #3 to Conscious Discipline Agreement #4590 to provide professional development through a virtual and in person format to early childhood teachers, staff and administrators continued into the 2021-2022 school year.
