STATUS REPORT - OUTSTANDING PROJECTS

Following are status reports on the following projects:

### BALLYSHANNON MIDDLE SCHOOL (BG #15-279 / REH #129-1214-A)

The project has been backchecked and currently awaits the contractor to submit the final request for payment and accompanying lien releases. Once the final Application for Payment has been certified, the BG-4 and BG-5 Contract and Project Closeout forms will be presented for approval at a future meeting.

### RISE ACADEMY (ACE) - RENOVATIONS (BG #21-131 / #129-1020-A)

Graybach is about a week into demolition and things appear to be going well. At this point the focus is to demolish and reconstruct the mid-level bathrooms and install the elevator shaft. We are also focusing on material availability and color selections at this time. Weekly progress meetings continue to be held on-site.

#### BOONE COUNTY HIGH SCHOOL -- ADDITION AND RENOVATIONS (BG #20-183 / REH #129-120-A)

Graybach continues to install the steel over the auditorium area and complete the interior floor slabs. The main push is for completion of the auditorium renovations which are scheduled to be complete by the first of August.

#### BOONE COUNTY HIGH SCHOOL -- PHASE 2 RENOVATIONS (BG #21-295 / REH #129-121-A)

This project is in the early stages of defining scope and budget – the initial BG-1 was presented for approval at last month's meeting and has been approved by the Kentucky Department of Education. Schematic Design and Design Development drawings will be presented late Summer and early Fall with final Bidding Documents anticipated for approval at the December meeting with award in February.

### BOONE COUNTY SCHOOLS - CONCRETE IMPROVEMENTS 2021 (BG #21-201 / REH #129-121-C)

Project has been awarded to Riegler Blacktop, shop drawing submittals have been reviewed and returned, and the preconstruction meeting has been held. Construction activities are starting now that school is out for the summer and project completion is anticipated by August 1.

# BOONE COUNTY SCHOOLS - PLUMBING UPGRADES (BOONE COUNTY, JONES, BURLINGTON) (BG #21-130 / #129-1020-E)

Project has been awarded to Elite Mechanical Services, shop drawings have been reviewed and returned, and the preconstruction meeting has been held. Construction activities are starting now that school is out for the summer and project completion is anticipated by August 1.

#### BOONE COUNTY SCHOOLS - TURF FIELDS (BG #20-184 / REH #129-120-B)

OHeil and Motz continue to make good progress. All of the fields, with the exception of Cooper High School, are almost complete. We still need to do the asphalt underlayment at Boone County and Conner High Schools and the rubber coating needs to be installed at Boone, Conner and Ryle High Schools once we have an extended period of dry weather.

## ERPENBECK ELEMENTARY SCHOOL - ROOFING (BG #21-165 / REH #129-1220-A)

Project has been awarded to ACE Exteriors, shop drawings are anticipated to be received for review this week, and the preconstruction meeting has been held. Construction activities are starting now that school is out for the summer and project completion is anticipated by August 1.

## JONES MIDDLE SCHOOL - ADDITION AND RENOVATIONS (BG #21-202 / REH #129-121-B)

The initial BG-1 was presented for approval at last month's meeting and has been approved by the Kentucky Department of Education. Schematic Design documents are being presented for approval at this month's meeting and final Bidding Documents are anticipated in August for an October award.

#### RYLE HIGH SCHOOL - FENCING (BG #21-120 / REH #129-920

Project has been awarded to R&M Fence, shop drawings are anticipated to be received for review this week, and the preconstruction meeting has been held. Construction activities are starting now that school is out for the summer and project completion is anticipated by August 1.

Monarch Construction continues to make good progress. Currently, the final flooring is going down in the fifth grade wing.
