A. Memorandum of Agreement with KVEC

Superintendent David Trimble shared details concerning the proposed Memorandum of Agreement with the Kentucky Valley Educational Cooperative who has requested full time services of Instructional Supervisor Johnny Belcher. Mr. Trimble gave complimentary remarks of Mr. Belcher recommending the Board approve the agreement due to Mr. Belcher's desire to accept the offer and his potential service to the region.

Instructional Supervisor Johnny Belcher gave sentiments and praises for the Pikeville Independent School District remarking that many mentors have shaped him professionally over the course of his career spent entirely at Pikeville. Mr. Belcher shared his desire to fulfill a pursuit of purpose through a regional influence as his career enters its last stages.
