Minutes of Special Meeting of June 15, 2021 Executive Session

Special Meeting of the Jefferson County Board of Education held at VanHoose Education Center Stewart Auditorium, Louisville, Kentucky, on Tuesday, June 15, 2021, at 5 p.m.
