## **AMENDMENT**

**THIS AMENDMENT** (this "**Amendment**") effective as of July 1st, 2021 (the "**Effective Date**") by and between **BOTTLING GROUP, LLC**, a Delaware limited liability company, and its affiliates and/or their respective subsidiaries collectively comprising Pepsi Beverages Company, with an office located at 4010 Crittenden Drive, Louisville, KY 40209 ("**Pepsi**") and **Spencer County Public Schools**, with its principal place of business at 207 W. Main St, Taylorsville, KY 40071 (the "**Customer**").

**WHEREAS**, Pepsi and the Customer are parties to the School District Agreement commencing on September 1, 2016 (as amended on October 11, 2016, June 12, 2017, June 7, 2018, and May 15, 2019 and June 15, 2021 the "**Agreement**"); and

**WHEREAS,** Pepsi and the Customer wish to modify certain terms of the Agreement and memorialize the same in writing.

**NOW, THEREFORE**, in consideration of these premises and the covenants herein contained, it is hereby agreed that, as of the Effective Date, the Agreement is hereby amended as set forth below. As used in this Amendment, capitalized terms defined in the Agreement and not otherwise defined in this Amendment, shall have the respective meanings assigned thereto in the Agreement.

- 1) Pepsi and Customer agree to extend the Term for an additional one (1) year period, expiring on June 30, 2022.
- 2) The chart in Section 5(B) is here deleted in its entirety, and replaced with the following:

If Pepsi proposes any new Products to the Customer during the Term, then Pepsi shall have the right to apply a different Commission Rate and/or Minimum Vend Price for such new Product.

- 3) Notwithstanding anything in the Agreement to the contrary, Pepsi and Customer agree that the only amounts payable to Customer during the extended Term are applicable Commissions and Rebates.
- 4) Each party represents and warrants to the other that it has the authority to enter into and perform under this Amendment; and that the execution and performance under this Amendment will not violate any agreements with, or rights of, any third party. This Amendment may be amended or modified only by a writing signed by each of the parties.
- 5) Except as may be expressly set forth herein, all terms and conditions of the Agreement shall remain in full force and effect.
