## **End-of-the-Year Special Education Reports**

Kentucky Department of Education (KDE) requires districts to verify various special education programming information at the end of each school year. Information that KDE and Office of Special Education Programs, (OSEP)- Federal Government collects informs them of the degree districts are meeting state and federal programming targets and/or are compliant with regulations governing the provisions of special education services. The following information was submitted to KDE – June 2021.

**Special Education Evaluation Report**. This report requires the district to submit evaluation information for students initially referred for services during the calendar year. The purpose of this report is to determine if the district followed state and district due process regulations (Referral, Evaluation, & Eligibility). This report excludes evaluations conducted throughout the school year for students in the reevaluation process.

> 2020-21 SY Due Process & Evaluations Completed within 60 Day Timeline: 100% Compliant.

Special Education Post-Secondary Transition Planning Report. This report requires a review of transition planning process for student's 16 years of age and older. Each student's due process file is reviewed to determine if federal, state and district compliance governing Post-Secondary Transition Planning occurred. Federal and state regulations require vocational agency coordination and transition services delivered to support students in planning for employment and/or continuing their education after exiting high school.

➤ 2020-21 SY Post-Secondary Transitioning Services/Programming: 100% Compliant with all federal, state, and local policies regarding Post-Secondary Transition Planning for all 41 students at NHS.

Special Education End of Year Expulsion Report. Report of behavior resolutions (Expulsion-with services) and (Expulsion-without services).

> 2020-21 SY Expulsion rate of students identified with special needs: 0%

**Special Education Exit Report/Graduation Rate.** This report captures the number of students transferring to another district within or out-of-state, and graduating with a diploma, or alternative diploma.

> 2020-21 SY Graduation Rate for students identified with special needs: 100%

## **Exceptional Children Operations**

- Internal Due Process Record Reviews On-Going. Goal: 70% of all student files reviewed for compliance by August 12, 2021.
- KDE Student with Special Needs Parent Survey On-Going.

  This survey asks parents/guardians to rate special education services and programming during the 2020-21 SY. Response Rate Goal: 25% + Favorable Ratings Goal: 90% + KDE Parent Survey Closes July 31, 2021. To encourage parent/guardian participation letters were sent home, teachers made reminder phone calls, and the survey is posted on various social media accounts. As of June 11, 2021, Newport's rate of response is 21%. Rank 3<sup>rd</sup> in Northern KY for highest parent response rate. See Special Education Parent Survey Response Rates for Northern KY for district rankings. Results of survey is scheduled to be reported to districts fall 2021.
