# Request for Safety and Security Funding from KDE & SB1

The Bullitt County Board of Education was awarded a grant from the Kentucky Department of Education as a result of the 2019 SB1 Safety and Resiliency Act. BCPS's amount was \$359,162.36 from an \$18M budget for building security improvements to all school districts in Kentucky. The Safe Schools and Finance Departments asked for approval to request reimbursement for the grant. Presented was the itemized list of services/upgrades installed during the 2020-2021 school year.
