

1. The goal is to help facilitate mental health services through Agency for students enrolled in the Erlanger-Elsmere School District.
2. During the term of this agreement, Erlanger-Elsmere School District agrees to:
 - Comply with all FERPA/HIPAA standards, as relevant, including having a signed parental/guardian release allowing communication between Erlanger-Elsmere School District and Agency regarding the student or students.
3. During the term of this agreement Agency agrees to:
 - Provide Erlanger-Elsmere School District with a signed parental/guardian release agreeing to mental health services being provided at school by Agency.
 - Maintain appropriate professional and liability insurance. Agency agrees that it shall be responsible for any and all claims, losses, liability, demands, and damages, and agrees to hold harmless and/or indemnify from any loss, damage claim, or expense incurred by Erlanger-Elsmere School District based solely on the negligence, errors or omissions by the officers, employees, and agents of Agency related to the performance of services conducted by Agency pursuant to this agreement.
 - Communicate with school staff when student is transitioning from in-patient care (if appropriate) to the school.
 - Complete the required Online Safe Schools Training, as required by Kentucky Department of Education, before contact with any student while at school.
4. Erlanger-Elsmere School District will not be paying for any of the services provided by Agency.
5. Either party may terminate this MOU after notice to the other party.
