HISTORY/BACKGROUND:

This is the tenth (10th) change order for the Secure Vestibule Entrances and Other Security Enhancements Project associated with Morel Construction Company. The original contract with Secure Vestibule Entrances and Other Security Enhancements Project was \$6,949,983.00. This change order for an additional \$16,274.00 with previous change orders of \$188,245.00 makes the new contract sum \$7,154,502.00.

Item No 1: Install two (2) panic devices at Taylor Mill entrance doors. Furnish and install two (2) panic devices at Kenton Elementary Entrance Doors. Provide cylindrical lock in lieu of mortise lock and revised strike at Taylor Mill SRO door.
