Consider / Approve the Bid Award with Graybach Construction for the White's Tower Elementary Addition and Renovations Project (BG 21-145) with Graybach Construction Contract.

HISTORY/BACKGROUND:

White's Tower Elementary is in need of additional space and some renovations to existing spaces. The original BG-1 (Buildings and Grounds) Construction Application was approved by the Kenton County Board of Education on December 7, 2020. Bids were opened and read on Thursday, July 8, 2021 for the White's Tower Elementary Addition and Renovations Project. Seven (7) bids were received: Graybach, Century, Schrudde & Zimmerman, Morel, Radius, Perkins/Carmack, and Ashley. Graybach was the lowest and best evaluated bid including Bid Alternates 1, 6, and 8.
