Division 02: Site Work and Demolition

02.01: - No items noted.

Division 03: Concrete

03.01: 2018.11.26 – Concrete contractor is preparing to tear out the recently poured stairs that were not properly done.

03.02: 2018.12.03 - The exterior concrete stairs have been torn out.

03.03: 2018.12.03 – The contractor determine the concrete at the entry vestibule is out-of-level about 7/8" across the width of the vestibule. This has resulted in the storefront system being out of level. It was determined that (3) sections of concrete will be removed and re-poured to correct the problem.

Division 04: Masonry

04.01: No items noted.

Division 05: Metals

05.01: 2018.11.26 - Corrective work on the stainless steel handrails is in progress.

Division 06: Carpentry

06.01: 2018.11.26 – Installation of the casework has started. The drawers were not constructed in accordance with the specifications. The contractor was notified and the drawers will be corrected.

06.02: 2018.11.26 - Installation of the solid surface window stools has started.



06.03: 2018.12.03 - Installation of the casework and countertops continues through the Office area.

Division 07: Thermal and Moisture Protection

07.01: 2018.12.03 – The roof copings arrived on site.

Division 08: Doors and Windows

08.01: 2018.11.26 – The doors have been installed on the entry storefront system. Repairs still have not been made to the defective areas.

08.02: 2018.12.03 – Attempted repairs on the storefront system are still not acceptable.

Division 09: Finishes

09.01: 2018.11.19 - Final painting of the interior walls is in progress.

09.02: 2018.11.19 – Installation of the perimeter angle for the ceiling grid has started.

09.03: 2018.11.19 – Final painting of the door frames is in progress.

09.04: 2018.11.19 – Drywall finishing of the bulkheads in the Lobby area continues. The reveals in the ceiling near the display case are being installed.

09.05: 2018.11.26 - The bulkhead in the vestibule and lobby have been finished.

09.06: 2018.11.26 – Installation of the ceiling grid is in progress.

09.07: 2018.12.03 - The Lobby ceiling has been painted.

09.08: 2018.12.03 – Painting continues throughout the space.

09.10: 2018.12.03 – Installation of the ceiling tiles is in progress.

Division 15: Plumbing and HVAC

15.01: 2018.11.19 - Ductwork has been insulated.

15.02: 2018.11.26 – Installation of grilles and diffusers in the ceiling grid is in progress.

15.03: 2018.11.26 – Installation of mechanical equipment continues in the Mechanical Room.

16.01: 2018.11.26 – Installation of the light fixtures in the ceiling grid is in progress.


16.02: 2018.12.03 - Light fixtures have been suspended in the Lobby.




