Dr. Pollio began his report by thanking all of the staff, students, families, and community partners who helped with the District's largest summer Backpack League and Lit & Camps ever. He stated that the District must continue to grow and expand to provide engaging out-of-school and summer learning opportunities for every student in JCPS. He then discussed the progress of facility improvements within JCPS. He concluded by addressing the current situation and guidance regarding COVID-19 prevention in K-12 schools. He acknowledged the difficult decisions and emphasized that the COVID-19 prevention strategies are the most important way to ensure in-person learning for K-12 schools.

#### **VIII. Action Items**

# A. A New Way Forward: Next Steps for the Opening of 2021-2022 School Year

Dr. Pollio and his team presented recommendations regarding the opening of schools and prevention strategies to help protect students and staff and slow the spread of COVID-19 across the District. The recommendations were taken directly from the Kentucky Department for Public Health recommendations and were in alignment with the U.S Center for Disease Control, the American Academy of Pediatricians, and the Kentucky Governor. They stated that the District had focused a great deal of attention to ensure inperson learning while maintaining a safe and healthy school environment for students and staff. The recommendations emphasized the implementation of plans to protect everyone on JCPS property, including those who are vaccinated and unvaccinated.

One of the key recommendations was for masks to be required for all vaccinated and unvaccinated students, staff, and visitors inside school property and on school buses.

The recommendations also included the following important topics:

- Vaccinations
- Masks and personal protective equipment (PPE)
- Physical distancing
- Screening testing
- Ventilation
- Handwashing and respiratory etiquette
- Isolation
- Quarantine and contact tracing
- Cleaning and disinfection
- Athletics and extracurricular activities

Each Board member had an opportunity to comment and ask questions.

Dr. Kolb asked for clarification regarding the process of making COVID-19-related guidance and questioned the possibility of having a COVID committee to meet regularly and be proactive in updating the guidance as needed. He expressed concern with the Delta variant and possible outdoor transmission and asked what the quarantine criteria were based on and wondered if it could be tightened up. He wanted to understand what the process would look like when we have a confirmed case. He asked about regular testing and encouraged the District to promote the availability and ease of vaccinations and testing for families. He asked for details regarding the plan for a K-5 extension for the Pathfinder School of Innovation. He concluded by questioning the impact of possible quarantines and wanted to ensure that each school has access to a nurse and mental health professional.

Chair Porter stated that she would be forwarding several emails that she had received from staff with questions regarding mask requirements. She wanted to ensure that accommodations would be made for students with medical needs. She acknowledged the importance of principal voice and the need to include them in decisions.

Dr. Shull asked who is eligible for the dual credit courses. He requested the Board receive a monthly data report regarding COVID. He thanked Board members and Dr. Pollio for his leadership during the pandemic. He concluded by encouraging parents to be respectful of others and to ask their children to do the same.

Ms. McIntosh reminded parents that the supplemental year that was allowed for 2020-2021 will no longer be offered going forward; that was a one-time thing. She also wanted to make sure that parents who have students with an Individual Education Program (IEP) are aware that those services will follow the student if they chose the Pathfinder Virtual School.

Mr. Marshall wanted to ensure that the needs of our ECE students are considered in all plans going forward. He asked what the procedures would be for teachers/staff who have a child at home who is required to quarantine. He requested an update on hiring/vacancies. He asked if parents would be able to keep students at home if a school outbreak becomes a concern. He concluded by expressing excitement with the start of inperson learning for the new school year.

Mr. Craig asked if the Board would continue to receive daily COVID reports which are also available to the public. He wanted to ensure that accommodations and exemptions would be made for students when needed. He stated that he is appalled by some of the comments from public speakers and expressed the need to remove politics from the situation and work together to safely move forward.

Chair Porter asked Dr. Pollio to confirm that the District will support all students and provide them what they need to be successful.
