Listed below is a courtesy copy of an advertisement to meet the requirements of KRS 160.470 (7)(b) which states in part "The district board of education shall advertise the hearing by causing the following to be published at least twice for two (2) consecutive weeks, in the newspaper of largest circulation in the county, a display type advertisement of not less than twelve (12) column inches..."

The Covington Independent Board of Education will hold a public hearing in the LOCATION on DATE, at TIME to hear public comments regarding a proposed general fund tax levy of 107.9 cents on real property and 108.1 cents on personal property.

The General Fund tax levied in fiscal year 2021 was 106.1 cents on real property and 108.1 cents on personal property and produced revenue of \$17,077,557.07. The proposed General Fund tax rate of 107.9 cents on real property and 108.1 cents on personal property is expected to produce \$18,332,683.30. Of this amount \$1,764,620.92 is from new and personal property. The compensating tax for 2022 is 103.8 cents on real property and 108.1 cents on personal property and is expected to produce \$17,693,985.66.
