Center Agreement

Northern Kentucky High School Varsity Bowling 2021/2022

It is mutually agreed by and between Boone County High School
(Name of High School)

and the **Florence Bowling Center** that:

1. A minimum of four (4) lanes will be leased and hired by the above-named high school consisting of 2 teams for a period of no less than two 2-hour practices per week beginning October 1, 2021, ending on February 9, 2022. The number of lanes leased is on a per team basis. E.g., if a school has both a boy and girls' team they will have 8 practice lanes, for a school only having one team they will receive 4 practice lanes.
2. A minimum of 9 competitive matches will be held with NKAC schools and the matches shall bowl based on negotiation with the host facility for day of the week and time for the match start, beginning on November 1, 2021 and ending January 31, 2022. The number of competition days/times may vary by school. Competition start times will be negotiated with the facility based on lane availability. Practice will start 10 minutes prior to the schedule starting time. The telescores will be started by front desk personnel and an announcement commencing the 10-minute practice session will also be done by the front desk.
3. The high school, through its school administration shall pay the center for rental of the lanes at the rate agreed to per team per season (\$600 per team). If a high school fields both a boys and girls team the total cost would be a two-team rate per season. Lineage fees shall be paid to the host facility no later than November 30, 2021.
4. All schools will be required to pay a \$50 tournament entry fee to the host school for each team entered in the Regional Tournament. This fee is paid directly to Bishop Brossart (Region 5) or Lloyd (Region 6).
5. For schools entering teams/players in the adapted or unified divisions, there is an additional fee of \$2.50 per person for adapted bowlers that will be required for practice sessions and the regional tournament fee. *The practice fees are paid via invoice to the host center and the regional tournament fee is paid to the host school (Bishop Brossart or Lloyd Memorial).*
6. It is understood and agreed by the parties that postponements due to severe weather, holidays, and acts beyond the control of the center or the high school which prevent the use of the lanes by the team, shall release the center and/or high school from any responsibility for damage or claims of any nature whatsoever. Postponements of matches can be made up at the request of the high school.
7. A total of 2 lanes will always separate high school bowling and open play. Matches will be accompanied with one practice pair for both schools.
8. **Additional Services Available Upon Request Are:**
 - *Hosting of invitational tournaments by host facility schools. Lineage associated with the tournament will be negotiated based upon total teams and likely time the lanes will be in use.*
9. Regional tournament events are the responsibility of the assigned school and all costs associated with this event will be negotiated with the host facility. **The regional host schools for the 2021-2022 season are: Region 5 – Bishop Brossart, Region 6 – Lloyd.** The host school will meet with their selection for a host facility a minimum of 60 days prior to the event to work out details. Host school will pay the host facility

\$50 per team for lineage for hosting the singles and team event. The adapted and unified events will pay an additional fee of \$5/team for a maximum cost of \$125 per school.

The above constitutes the agreement made between

and the **Florence Bowling Center** in its entirety. This is not a legally binding contract but is a signed agreement between the parties and can only be cancelled with the agreement of both parties with a minimum of 60 days notification.
