RETURN TO SCHOOL DATE _____

_____ Students quarantined due to symptoms may qualify for early end of quarantine and may return to school upon documentation of a negative Covid-19 test result to the school nurse, plus improvement of symptoms.

_____ Students quarantined due to exposure (close contact) AT SCHOOL who remain asymptomatic may participate in the **test to stay** program.

_____ Students quarantined due to exposure (close contact) OUTSIDE OF SCHOOL, who remain asymptomatic may qualify for early end of quarantine by submitting a negative Covid-19 test result that was drawn on or after _____. Covid-19 testing is available at the School Based Health Center (SBHC) located in the Intermediate School. Call 291-1910 to speak to a school nurse to arrange testing.

*****FULLY VACCINATED STUDENTS ARE NOT REQUIRED TO QUARANTINE UNLESS THEY ARE EXPERIENCING SYMPTOMS OF COVID-19 BUT ARE RECOMMENDED TO GET A COVID-19 TEST 3-5 DAYS AFTER THEIR EXPOSURE.**

Parents/guardians remain responsible for reporting any changes in student health status to the school nurse at 859-291-1910.

TEST TO STAY PROGRAM

Eligibility: when an exposure (close contact) is identified as having occurred IN SCHOOL, the parent/guardian may elect to have the student participate in the *test to stay* program.

Test to Stay Protocol:

1. The parent/guardian exercises this option by going to www.ethosbacktoschools.com/ and enrolling their student in the program.
2. The parent/guardian then notifies the school nurse at 859-291-1910 that they have enrolled their student in the *test to stay* program. At this time, the school nurse will inform the parent of the test dates that will be required.
3. The parent will escort their student to their student's school building for rapid testing at the start of the school day.
4. Ethos lab personnel will be onsite to perform rapid Covid-19 testing on each test to stay participant. Those participants receiving a negative test result will be allowed to attend school for the day and the parent/guardian may leave at that point. Those participants receiving a positive test result will be escorted back home by the parent/guardian. After five (5) days of test surveillance, the student is cleared to return to normal operations.

****Bus Services are not available to students in the *Test to Stay* program.**

EDUCATIONAL SERVICES

All students who are quarantined receive educational services using Google Classroom, on-line digital learning platforms, and/or by paper packets provided by the student's teachers. Children who engage with this instruction and complete assignments daily do not earn an attendance event. Students who do not engage in learning earn attendance events. Students too ill to work may be eligible for home/hospital instruction. Questions concerning educational services should be directed to:
