Rationale- The Technology Activity Report (TAR) is a collection of technology purchases and employee pay associated with technology for the prior fiscal year. It is generated from a program written specifically for the Kentucky Department of Education (KDE) in our MUNIS software. This program allows the school districts to print a standard commodity report for the technology purchases using the commodity codes for such items. The requirement is for the Technology Activity Report to be submitted by all school districts to KDE. The purpose is to report technology expenditures to fulfill the KETS Master Plan. It is approved each year by the board and it must be submitted to KDE so that we can get our KETS offer of assistance.

Rationale- The current District Facilities Plan (DFP) was developed by the Local Planning Committee and approved by the Board and the Kentucky Board of Education (August 2019). Amendment No. 1 which removed the renovation of the existing middle school and added the construction of a new middle school as Priority 1a.3 was approved by the KBE in February 2021. Site acquisition is administered by the Kentucky Department of Education (KDE) under 702 KAR 4:050 Building Sites, Inspection & Approval. KDE's evaluation of the documents determined that pursuant to Section 5 of the regulation for final approval the Madison County Board of Education must request approval by the Kentucky Board of Education to acquire this property for which the acquisition and site preparation costs exceed ten (10) percent of the maximum budget for the middle school project.
