CONTRACT EMPLOYING SUPERINTENDENT

This AGREEMENT, made and entered effective the 1st day of July, 2018, by and between the BOARD OF EDUCATION OF GALLATIN COUNTY, (hereinafter the "BOARD"), party of the first part, and LARRY B. HAMMOND, (hereinafter referred to as the "SUPERINTENDENT"), party of the second part, and authorized by action at a lawful meeting of the BOARD held on the 7th day of May, 2019.

WITNESSETH:

NOW, THEREFORE, the BOARD and SUPERINTENDENT, for the consideration herein specified, agree as follows:

IT IS AGREED:

I. TERM OF EMPLOYMENT

SUPERINTENDENT is hereby hired and retained for a term commencing on July 1, 2019, and continuing through June 30, 2023, as Superintendent of Gallatin County Schools, Gallatin County, Kentucky.

II. DUTIES

The duties and responsibilities of the SUPERINTENDENT shall be all those duties incident to the Office of Superintendent imposed by the law and regulations of the Commonwealth of Kentucky and in keeping with Board policy. Other duties and responsibilities as may be needed from time to time may be assigned to the SUPERINTENDENT by the BOARD.

III. OUTSIDE ACTIVITIES

The SUPERINTENDENT and BOARD recognize the advisability and on occasion the necessity of the SUPERINTENDENT to attend seminars, courses, or programs conducted or sponsored at the local and state levels. The BOARD shall permit a reasonable amount of time for the SUPERINTENDENT to attend such meetings, and agrees to pay the necessary fees, travel and subsistence expenses as it may approve or as may be provided for in local board policy.

IV. COMPENSATION:

During the term of this Contract, the SUPERINTENDENT shall be compensated at the daily rate equal to the SUPERINTENDENT'S Daily Wage Threshold as determined by the Kentucky Teachers' Retirement System. As of today's date that Daily Wage Threshold rate is Five Hundred Forty-Eight Dollars and Eighty-Six Cents (\$548.86) per workday. The compensation herein provided shall be paid in bi-monthly installments on the same dates administrators employed full-time by the school district are paid.

V. WORKING DAYS AND BENEFITS

- a. Working Days -- It is understood and agreed that the SUPERINTENDENT shall work Monday through Friday of each week for an average of 20 days per month, and 240 working days per school year. The SUPERINTENDENT shall only be paid for days worked.
- b. <u>Expenses</u> -- the BOARD shall pay or reimburse SUPERINTENDENT for reasonable expenses approved by BOARD and incurred by the SUPERINTENDENT in the continuing performance of his duties under

X. <u>FULL AGREEMENT:</u>

This Agreement, which shall be executed in duplicate originals, contains all of the terms agreed upon by the parties with respect to the subject matter hereof and supersedes all prior agreements, arrangements, understandings and communications between the parties concerning the subject matter hereof, whether oral or written, and shall be construed in accordance with the laws of the Commonwealth of Kentucky.
