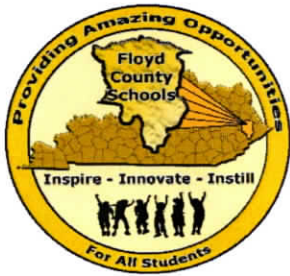
**Recommended Action:** Approve Central Restaurant Products as the vendor for outdoor seating.
