

August 23, 2021 SBDM Meeting

In Attendance: Brad Campbell, Erin Goetz, Angela Buschle, Jennifer Sparks, Scott Meyers, Rick Wolf, Jessica Hoffman

Meeting called to order at 4:03 PM by Chairperson Meyers.

#### Opening Business

- a) Approval of the Agenda
  - a. Motion made by Ms. Buschle, second made by Mr. Campbell. No objections.
- b) Approval of the July Minutes
  - a. Motion made by Mr. Campbell, second made by Ms. Goetz. No objections.
- c) Good News Report
  - a. 39 students at Gateway
    - i. Record number of students attending!
  - b. 13 Juniors at ATC
  - c. 13 Seniors at ATC
  - d. Braden Bickers, a junior, is in the Craft Academy Program at Morehead State
  - e. Orientations went very well, discussed several programs with 9<sup>th</sup> grade orientation which was not previously held
  - f. Assistant Principal Chris Wright earned his Ed.D.
  - g. Ms. Goetz shared that her Life Skills classes will have an investing program after Labor Day
  - h. Ms. Buschle's class re-started the coffee cart program. Using digital system with visual prompts for student supports.
    - i. New classroom set up working well
  - i. Lasagna Love partnership in Ms. Buschle's class. Her Friday cooking class will participate once per month by cooking a lasagna and she will drop it off.
- d) Public Comment
  - a. No members of the public in attendance.

#### Student Achievement Report/Data

- a) Assessing Student Achievement
  - a. DHS Current College and Career Readiness Rate-
    - i. We are currently at 12/52 kids that are college or career ready for 23.07%. These students mostly got transition ready through the ACT.
    - ii. Of the students who are not currently college/career ready:
      - 1. 5 should get career ready through the Skilled Trades program
      - 2. 8 should get college ready through Gateway courses.
      - 3. 11 should get career ready through the ATC
    - iii. This would put us at 69% CCR or 36/52. Barring anything crazy, this should be our floor for the school year.
    - iv. Of the 16 students who don't have an "automatic" route to CCR

1. 12 can become CCR from either the ASK exam or the KYOTE test or the ACT
2. 4 almost certainly not going to reach CCR
  - a. Of these 4, 3 transferred after high school began
  - b. One struggled considerably with virtual learning
3. This would make the highest attainable CCR number 92.3%

#### School Improvement Planning

- a) Progress Monitoring/Title I – Mr. Wolf shared the Title I and Title II Allocation.
  - a. PD Funds are for entire district, no state money for PD.
  - b. Substitutes – only for those who sub for a teacher who is paid through Title I
  - c. Title I monies follow the student, so services must be sent to the district or school the student is attending through collaboration with those schools.

#### Budget Report

- a) Mr. Meyers presented the budget report to council.
- b) Teacher funds \$100 per certified staff member must be spent by September 30, 2021
- c) Copier fund decreased by \$1416, surplus was allocated for school supplies. Voted on last month, monies need moved in budget.

#### Committee Reports

- a) No committee reports were scheduled for the month of August.

#### Bylaw or Policy Review

- a) Alignment with State Standards Plan Policy 1.02 (1<sup>st</sup> Reading). Ms. Goetz makes a motion to approve first reading. Ms. Buschle seconded the motion. No objections.
- b) Working on streamlining SBDM policies to include only state recommended policies and move non-student achievement policies to Student Handbook

#### New Business

- a) Board Report—Mr. Meyers shared tonight's board report with council for informational purposes.
