LETTER OF AGREEMENT MODIFICATION

BETWEEN

KENTUCKY SCIENCE AND TECHNOLOGY CORPORATION AND JEFFERSON COUNTY BOARD OF EDUCATION

To Implement the



Access to Algebra Program



Due to COVID-19, the PSAT 8/9 was not administered to students at Farnsley Middle School during the 2019-2020 academic year. Due to the inability to administer the exam, certain elements and funding of the Access to Algebra program have been extended into the 2023-2024 academic year. Upon mutual agreement, KSTC and Jefferson County Board of Education agree to modify the original Letter of Agreement, dated April 22, 2020, as outlined below.

- Exam Fee Reimbursement of a national college readiness exam as selected by AdvanceKentucky for 2023-2024 8th grade students at Farnsley Middle School.
- Student Incentives for 2023-2024 8th graders meeting the math benchmark on a national college readiness exam or meeting a pre-determined growth goal set by AdvanceKentucky.
- Teacher and Administrator Bonuses to be awarded to 2023-2024 Middle School math teachers and administrators based on the above-mentioned exams for reaching school performance goals set by AdvanceKentucky. Goals are set on a national college readiness exam and shared collaboratively.
- Content Review Session expenses for 2023-2024 8th grade students will be reimbursed.
 A Content Review Session budget will be provided to Farnsley Middle School and will be based on 2023-2024 8th grade enrollments. Reimbursement will be made upon receipt of vendor invoices and additional documentation as directed by AdvanceKentucky.

The terms of this extended/modified agreement shall end on July 31, 2024.

This AdvanceKentucky Letter of Agreement is entered into upon mutual agreement to the terms outlined by and between *Kentucky Science and Technology Corporation* (KSTC) a Kentucky nonprofit corporation, and *Farnsley Middle School/Jefferson County Public Schools* and documents the role of *Farnsley Middle School/Jefferson County Public Schools* and *Kentucky Science and Technology Corporation* with respect to a multi-year replication of the AdvanceKentucky's Access to Algebra Program.

SECTION 1.0 - TERM OF AGREEMENT

The Term of the Agreement shall commence on April 22, 2020 and end on July 31, 2023, subject to annual renewals between *Farnsley Middle School/Jefferson County Public Schools* and the *Kentucky Science and Technology Corporation* based on ongoing performance and pending availability of funding.

SECTION 2.0 - RECITALS

- a) Kentucky Science and Technology Corporation is a non-profit corporation that oversees the coordination, planning, management, implementation and funding of AdvanceKentucky, its teacher training and incentive program involving the College Board's Advanced Placement Program (AP) in mathematics, science, and English (MSE) courses and pre-AP preparation for these courses including the Access to Algebra program. This program includes extensive formal and informal training of teachers, additional time on task for students, financial incentives based on academic results, cultivation of teachers who provide leadership to the Program by mentoring other teachers, and measurement and accountability for results. The overall goal is to increase the number of students prepared for advanced STEM coursework in high school including a focus on inclusion of students traditionally underrepresented in advanced courses.
- b) Based on the continued and proven success of the program under AdvanceKentucky, Kentucky Science and Technology Corporation solicited responses from eligible public Districts that were interested in operating the Access to Algebra Program in a given school, including Farnsley Middle School/Jefferson County Public Schools.
- c) Farnsley Middle School/Jefferson County Public Schools expressed interest to Kentucky Science and Technology Corporation addressing how it intends to implement and operate the Access to Algebra Program in its school with full integrity to the concept of increasing the number of

students participating in advanced math courses and meeting college readiness benchmarks in math.

- d) Kentucky Science and Technology Corporation conducted an initial assessment of the Farnsley Middle School/Jefferson County Public Schools math program to ascertain the School's focus, commitment, and potential for success in the implementation and management of the open enrollment model, with a particular focus on adopting an open enrollment approach serving many more students traditionally underrepresented in advanced middle school math.
- e) Kentucky Science and Technology Corporation has determined that committing Program funding to support Farnsley Middle School/Jefferson County Public Schools for the purposes of and on the terms and conditions stated in this Agreement and related teacher-specific agreements will further the stated purposes of increasing the number of students meeting national math benchmarks.
- f) Farnsley Middle School/Jefferson County Public Schools agrees to implement and support proven strategies outlined in the Access to Algebra Program to significantly increase the number of students meeting benchmark on a national math assessment, to increase the number of students eligible for 8th grade Algebra 1, and to use the funds paid to the school solely to operate the program in accordance with Kentucky Science and Technology Corporation's directions and requirements under the AdvanceKentucky Access to Algebra Program, as further described below.

In furtherance of the previously stated goals, both parties recognize the following key components of AdvanceKentucky that have demonstrated success.

SECTION 3.0 – KSTC OPERATIONAL EXPECTATIONS

In addition to the Elements of Success (*Attachment A*) both parties recognize the following components and strategies to realize the successful implementation of the Program:

- a) An effective Kentucky-based non-profit organization that will manage and implement the Access to Algebra Program for *Jefferson County Public Schools* by providing:
 - i. <u>Content Area Support</u>: Experienced and well-respected staff and teacher trainers with first-hand familiarity and success in building successful accelerated math programs;
 - **ii.** <u>Logistical Support</u>: to maximize the use of technology, materials and resources necessary for a successful Program;
 - **iii.** <u>Goal Setting:</u> A results-oriented culture characterized by measuring the number of students taking and succeeding in advanced MS math courses across all demographics.
- b) Administrative support from Jefferson County Public Schools that will address:
 - i. <u>Culture:</u> Cultivate, support, and maintain a culture of high expectations for teachers and students that is inclusive, i.e., embraces an open enrollment approach in advanced courses.
 - ii. <u>Accelerated Math Program</u>: Establish accelerated math pathways starting in Grade 6 or 7, with outreach to the 5th and 6th grades as course schedules are determined.
 - iii. <u>Teacher Professional Development:</u> Support teacher participation in Laying the Foundation (LTF) professional development and training;
 - **iv.** <u>Student Recruitment:</u> Actively recruit all students to be a part of an accelerate math program with specific attention to the following areas:
 - Underrepresented Students: Create access to accelerated math courses for underrepresented school populations and recruit underrepresented school populations.

- o Remove Barriers to Accelerated Math Participation: Identify district, school, or department policy, unreasonable entrance exams, or gatekeeping of any kind that directly or indirectly hinders accelerated math participation.
- v. <u>Accurate Data Reporting:</u> Provide the **Kentucky Science and Technology Corporation** with data, documentation, and Program information in a timely and meaningful fashion. (Attachment B).

c) A Classroom Experience that includes:

- i. <u>High Expectations:</u> High expectations regarding open enrollment and student academic achievement;
- ii. <u>Qualified Faculty:</u> As needed hire/assign highly qualified math faculty and support teachers by providing access to advanced level, content-focused teacher training that supports MS math classrooms.
- **iii.** <u>Exam Expectations:</u> as a school-wide strategy encourage all students to perform with their best effort on the PSAT 8/9 exam.

SECTION 4.0 – ACCESS TO ALGEBRA PROGRAM GOALS FOR FARNSLEY MIDDLE SCHOOL

- a) Open Enrollment: Both parties firmly support the goals of KSTC/AdvanceKentucky that center around Open Enrollment in advanced math, namely to have more students prepare for and meet 8th grade benchmark for math on a national exam.
- b) Farnsley Middle School Goals: Increase the number, set by AdvanceKentucky, of 8th grade students meeting benchmark above 2020 baseline.
- c) Future Goal Setting: Fair and reasonable school goals will be set annually by AdvanceKentucky based on prior year PSAT 8/9 results.

SECTION 5.0 - AGREEMENT

NOW, THEREFORE, in consideration of the foregoing and the mutual obligations created hereby, *Kentucky Science and Technology Corporation* and *Farnsley Middle School/Jefferson County Public Schools* agree as follows:

Each year beginning June 1, 2020 and continuing until July 31, 2023, under mutually agreed upon annual renewals of the terms of this Agreement and pending availability of funds, *Kentucky Science and Technology Corporation* will provide the following to, or for the benefit of, *Farnsley Middle School/Jefferson County Public Schools*:

a) Stipends, incentives and threshold bonuses:

- i. Each designated *MS math teacher* will receive up to a \$340 stipend in return for participating in specific activities. See *Attachment C* for sample LOA with these individuals.
- ii. Designated MS math teachers also will have an opportunity to receive a threshold bonus up to \$500 based on the total number of 8TH grade students meeting math benchmark. A separate LOA for each designated MS math teacher detailing in advance the threshold bonus number will be issued by Kentucky Science and Technology Corporation by late Fall of each school year. See Attachment C.
- **iii.** Students will receive \$50 for meeting benchmark. The \$50 will be earned by 8th grade students who have either met national benchmark on the PSAT 8/9 or a predetermined growth goal determined by AdvanceKentucky.

- iv. One MS math teacher will serve as Content Coordinator for Farnsley Middle
 School/Jefferson County Public Schools and receive up to \$400 paid by Kentucky
 Science and Technology Corporation to Farnsley Middle School/Jefferson County
 Public Schools. This stipend is in addition to any stipend earned as a classroom
 teacher. See Attachment D for sample LOA with this individual.
- v. A designated *School Administrator* will have an opportunity to receive a threshold bonus of **\$500** based on the total number of 8TH grade students meeting math benchmark. A separate LOA for each designated MS math teacher detailing in advance the threshold bonus number will be issued by *Kentucky Science and Technology Corporation* by late Fall of each school year. *See Attachments E for sample LOA with this individual*.

b) Teacher training costs and exam fees:

- i. *Kentucky Science and Technology Corporation* will provide funding for 7th and 8th grade PSAT 8/9 exams.
- **ii. Kentucky Science and Technology Corporation** will provide funding for registration fees and negotiated travel costs for all MS math teachers to attend Pre-AP trainings sponsored by AdvanceKentucky.

c) Equipment and supplies costs:

- i. Pending final negotiation *Kentucky Science and Technology Corporation* will reimburse up to \$1,000 and up to \$15 for each 8th grade enrollment in a participating math course for equipment and supplies directly supportive of MS math courses.
- d) Kentucky Science and Technology Corporation also will implement, manage, and report the results of the Program in collaboration with Farnsley Middle School/Jefferson County Public Schools as outlined below:
 - i. Create and provide all forms needed for the Program.
 - ii. Provide detailed reports on the results of the Program to external sponsors and Farnsley Middle School/Jefferson County Public Schools, including how all incentives are to be allocated based on reported performance.
 - iii. Annually review each MS math department's performance based on PSAT 8/9 exam results and whether they carried out their designated responsibilities that are conditions of earning the MS math teacher stipend. MS math teacher responsibilities are listed in the sample LOA in Attachment C.
 - iv. Assist *Farnsley Middle School/Jefferson County Public Schools* in recruiting and developing MS math Content Coordinators.
 - v. Communicate regularly with Content Coordinators and assist them in carrying out their responsibilities. Content Coordinator responsibilities are listed in sample LOA in Attachment D.
 - vi. Award earned bonuses to each MS math teacher based on the number of 8th grade students meeting the PSAT 8/9 math benchmark as reported by College Board in comparison to pre-set threshold goals and disburse the bonuses as agreed upon with Farnsley Middle School/Jefferson County Public Schools.
 - vii. Award earned bonuses to designated administrator based on the number of 8th grade students meeting the PSAT 8/9 math benchmark as reported by College Board in comparison to pre-set threshold goals posted in annual LOAs. Designated administrator responsibilities are listed in sample LOAs in *Attachments E and F*.
 - viii. Provide curricular support as needed to MS math teachers and Content Coordinators in the Program.
 - ix. Provide assistance and relevant data for school administration.
 - **x.** Provide Vertical Team meeting assistance for MS math teachers in the Program.

- xi. Purchase agreed upon Program materials as feasible.
- xii. Follow general timeline of activities noted in **Attachment G**.
- e) For implementation of the Access to Algebra Program, Kentucky Science and Technology Corporation will provide reimbursement for the following Program Costs:
 - **I.** Kentucky Science and Technology Corporation will provide funding for 7th and 8th grade 2020 Spring PSAT 8/9 exams.
 - **II.** *Kentucky Science and Technology Corporation* will reimburse up to \$1,000 and up to \$15 for each 2020-2021 8th grade enrollment in a participating math course for equipment and supplies directly supportive of MS math courses.
 - III. Upon final negotiation, each designated *MS math teacher* will receive up to a \$340 stipend in return for participating in specific activities during the 2020-2021 school year.
 - IV. Upon final negotiation, one MS math teacher will serve as Content Coordinator for Farnsley Middle School/Jefferson County Public Schools and receive up to \$400 for specific activities during the 2020-2021 school year. This stipend is in addition to any stipend earned as a classroom teacher.
 - V. A designated school administrator will have an opportunity to receive a threshold bonus of \$500 based on the total number of students meeting national benchmark on the PSAT 8/9 exam. A separate LOA for the administrator detailing threshold bonus numbers will be issued by Kentucky Science and Technology Corporation by late Fall each school year. See Attachment E for sample LOA with this individual.
 - VI. All 2020-2021 8th grade *students* are eligible to receive \$50. The \$50 will be earned by 8th grade students who have either met national benchmark on the PSAT 8/9 or a predetermined growth goal.
 - VII. Funding for content review session(s) to help prepare students for the PSAT 8/9.
- f) Each year upon annual renewals of the terms of this Agreement and pending availability of funds, Farnsley Middle School/Jefferson County Public Schools agrees to do the following to promote maximum program efficiency and student results:
 - i. Use appropriate resources to help identify students' capabilities for participating in rigorous MS math courses with specific emphasis on 8th grade Algebra 1.
 - ii. Allow Content Coordinator to complete his/her extracurricular responsibilities in setting up Vertical Team meetings.
 - **iii.** Provide support for MS math Vertical Team meetings including but not limited to arrangement for facilities and other logistical assistance.
 - iv. Negotiate funds for equipment, instructional materials, and technology directly supportive of MS math courses as determined by Kentucky Science and Technology Corporation, Farnsley Middle School/Jefferson County Public Schools and the Content Coordinators up to \$1,000 per school per year plus up to \$15 per actual enrollment 8th grade MS math enrollment.
 - v. Annually report necessary data to *Kentucky Science and Technology Corporation* to measure the results of the Program as described in *Attachment B*.
 - vi. Formally authorize the release of annual results data to *Kentucky Science and Technology Corporation* pertinent to the Program as explained in *Attachment B*.
 - vii. Collaborate with *Kentucky Science and Technology Corporation* on matters regarding the Program.
 - viii. Support the effort of all Program participants during PSAT 8/9 testing by establishing a testing environment conducive to success and by ensuring students are prepared for the exam, which may include a prior Content Review Session for students.

SECTION 6.0 – PROGRAM BUDGET & FUNDING PROCESS

- a) Program Budget In Attachment F, Kentucky Science and Technology Corporation provides a written funding scenario for Farnsley Middle School/Jefferson County Public Schools that outlines and identifies all Program costs supported by Kentucky Science and Technology Corporation, any donors, and the School. Farnsley Middle School/Jefferson County Public Schools shall comply with the budget scenario and Kentucky Science and Technology Corporation has the discretion to amend or revise pending compliance with the Program and unanticipated changes in personnel.
- b) The Funding Process Pursuant to this Agreement and its Attachments, Kentucky Science and Technology Corporation is committing funding to assist Farnsley Middle School/Jefferson County Public Schools in implementing and operating the Program. Funding is provided to Farnsley Middle School/Jefferson County Public Schools, its designated Administrator of Record, MS math teachers and Content Coordinators, qualified students, and vendors to pay for eligible expenses, as identified in the Attachment F and subject to Kentucky Science and Technology Corporation verification and approval based on results. The General Timeline of Activities, Reports and Payments is outlined in Attachment G.

SECTION 7.0 – GENERAL PROVISIONS

a) Relationship of the Parties - Kentucky Science and Technology Corporation is an independent corporation and, subject to the terms of this Agreement, shall have the sole right to supervise, manage, operate, control and direct the performance of the services provided pursuant to this Agreement. The personnel and staff of Kentucky Science and Technology Corporation (KSTC) are employees of KSTC and shall not, for any purposes, be considered employees or agents of Farnsley Middle School/Jefferson County Public Schools.

Nothing in this Agreement shall be deemed or construed to establish a partnership, joint venture, employer-employee relationship or any other relationship between the parties. *Farnsley Middle School/Jefferson County Public Schools* shall indemnify KSTC against any damages and costs incurred by KSTC related to this Agreement. KSTC shall not be responsible for any debts or obligations of *Farnsley Middle School/Jefferson County Public Schools*, and shall not sign as a guarantor or co-signer on any instrument for *Farnsley Middle School/Jefferson County Public Schools*.

- b) <u>Limitation on Liability</u>. To the fullest extent permitted by law and notwithstanding any other provision of this Agreement, neither KSTC nor KSTC's officers, trustees, partners, employees, agents, subcontractors or consultants shall be liable for any claims, losses, costs or damages whatsoever arising out of, resulting from or in any way related to this Agreement or the Program, included but not limited to the negligence, professional errors or omissions, strict liability, breach of contract, or express or implied warranty of KSTC.



KEY COMPONENTS

Content Focused Teacher Training includes training for all MS math teachers and special education teachers teaching math to attend LTF MS math training.

Supplies and Equipment per student funding to directly enhance math instruction and facilitate implementation of LTF math lessons. The amount will be calculated on 8th grade enrollment numbers but may be used across all middle school grades.

Vertical Teaming stipends will be provided to all MS math teachers to attend four vertical teaming events. The vertical meetings will focus on increasing the number of students meeting benchmark on the spring PSAT 8/9 exam.

Content Coordinator will be one math teacher serving as lead organizer and point of contact for AdvanceKentucky. This teacher will be responsible for coordinating the vertical team meetings and corresponding with program mentors and AdvanceKentucky staff.

Teacher and Administrator Bonuses will be awarded to MS math teachers and administrators for reaching school performance goals set by AdvanceKentucky. Goals are set on the PSAT 8/9 and shared collaboratively.

Student Incentives are given to each 8th grade student meeting the math benchmark on the PSAT 8/9 or meeting a pre-determined growth goal set by AdvanceKentucky.

Time on Task will be financially supported to provide students with additional test prep outside of the normal instructional school hours.

Exam Fee Support will be given to provide students, excluding FMD students, with a nationally recognized college readiness math exam.

Teacher Mentoring will be provided as requested.
