**AGENDA ITEM (ACTION ITEM):**

Rescind the Award to Willard Wheeler for Auction 2261536 - Bus #33 and Auction 2260422 - Bus #45 as awarded at the February 4, 2019 Board Meeting. Consider/Approve: A refund to Willard Wheeler for \$963.00 for 2 buses awarded at the February 4, 2019, Board Meeting.

**HISTORY/BACKGROUND:**

A protest was issued by Willard Wheeler on February 11, 2019, that the KCSD advertisement on PublicSurplus.com did not reflect that Bus #33 in Auction 2261563 and Bus #45 in Auction 2260422 did not have engines or transmissions. It was discovered that Mr. Wheeler's complaint is valid and the buses are missing engines and transmissions. Mr. Wheeler would like a refund of his purchase amount for Bus #33 and Bus #45. Mr. Wheeler has taken possession of the other three buses awarded.

**FISCAL/BUDGETARY IMPACT:**

Mr. Wheeler paid with a cashier's check a total of \$2,589.40 the amount from the original February 4, 2019 Award plus the Buyer's Premium Fee of \$169.40 (7%) on February 11, 2019 (see attached original Invoice #2-6-19-1). Upon approval of the recommendation, the Kenton County School District will need to distribute Mr. Wheeler a refund of \$963.00.

**RECOMMENDATION:**

Rescind the Award to Willard Wheeler for Auction 2261563 - Bus #33 and 2260422 - Bus #45. Refund Mr. Wheeler the amount of \$963.00.
