Consider/Approve Consider/Approve Dixie Heights charging a student fee of \$25 per student (\$5 for reduced and \$0 for free lunch qualified students) to participate in June 2019 Summer School for credit recovery.

<u>APPLICABLE BOARD POLICY:</u> 09.15 Student Fees

HISTORY/BACKGROUND:

The purpose of the summer school program is to allow an opportunity for students to recover credits they failed to earn during the regular school year. Our students who are free and reduced will have their fee either waived or reduced to (\$5) of the cost for the program. Students will be expected to come one day per week for check-in/instruction/tutoring purposes, but they could come in each day of the program for support and help. The students will be expected to do work on-line from home. The students will have 4 weeks to complete their course(s). The money collected will cover the cost of the instructor's time in implementing, instruction, and monitoring the completion of classes.

Budgetary Considerations

Plan for Credit Recovery for this year (2019 summer)

- 1. Dates; June 3rd through June 28th, Monday-Thursday (4 days a week), Hours will be 8-11am.
- 2. Blended summer school: Students will be required to report to school 1 day a week for check-in purposes. Students can come in every day if they need in order to make adequate progress or complete classes faster.
- 3. Instructors
 - a. Instructional assistant from SWS will be work each day: 3 hours day + 0.5 prep= 3.5 hours per day, 4 days a week= 14 hours week X 4 weeks= 56 hours x 21.10 per hour= \$1,181.60
 - b. Teacher= 3 hours per week monitoring/entering grades. 3 hours week x 4 weeks= 12 hours x 33.00 per hour= \$396
 - c. Special ed teacher= contingency on if needed due to special education student needs. 4 hours per week x 4 weeks- 16 hours x 33.00= \$528
 - d. Total projected cost= \$2,105.60

Student Projections for 2019 summer school:

Student population is 36% free and 4% reduced.

Failure numbers from 1st and 2nd trimester indicated that 16% of our population of students failed at least 1 class.

- 1. Total enrollment: 1462 x 0.16 = 230 students will be eligible for summer school.
- 2. If we get 50% of these student to participate= 115 students attending. (last years number of attendees was 112, so this seems reasonable)
- 3. 65% of students who fail are Free or reduced.
 - a. 230 x .65= 150 students potentially who fail are Free/reduced
 - b. 36% Free x 150 students= 54 students
 - c. 4% reduced x 150 students= 6 students
- 4. Overall Cost
 - a. 150-54= 96 students that could pay full price.
 - b. 6 student who would pay 0.16% of cost
 - c. 2,106/96-\$22.00
- 5. Proposed cost: \$25 per student to attend summer school program. This would allow for some variation in regards to students who attend that may or may not be able to pay.
