<u>APPLICABLE BOARD POLICY</u>: Capital Construction Process – 702 KAR:160

HISTORY/BACKGROUND:

The original BG-1 Application was approved by the Board on February 6, 2017, with estimates listed for the Guaranteed Energy Performance Contract. Pursuant to KDE regulations a revised BG-1 is required to be issued to reflect actual bid and bond results once they have been awarded. This revised BG-1 details those changes and is \$20,000.00 less than the original construction application.
