Principal Robert Jones, recognized other members of the Elementary Cross Country team and their placement in the State Competition. He also introduced the new assistant principal at Pikeville Elementary, Ms. Glenda Adkins. She will make the transition over the next few days from classroom to administration.

Principal Brandon Blackburn shared updates regarding Report Cards being sent home and the upcoming PHS Open House. He also bragged about the success of the PJHS Academic Team in recent meets. He shared updates regarding recent athletic competition successes and events surrounding Homecoming Week.
