Good afternoon. Wanted to share with you information to get on your calendar if you or your school has an interest.

In working with our regional Board of Control member Greg Howard, the regional representative for Regions 3 and 4, we are inviting your school to provide input on an upcoming agenda item for the Board of Control. We will get together at noon CT on Thursday, November 11 at the Logan County Career and Technical Center, [2400 Bowling Green Rd. | Russellville, KY 42276](#). Greg said he would gladly provide lunch.

At its November 17 meeting, the Board will be looking at a routine request for placement of a new school in a basketball region (Foundation Christian Academy) that is required by policy, as well as a request from Monroe County for an alignment adjustment. To that end, if you have input, we would love to hear it from you. With the placement of Foundation Christian in the appropriate space in District 14, it is important that all options be reviewed for future years.

There is no set agenda, and no official vote will occur, but we can discuss options going forward. Probably should keep a couple of things in mind:

- There has been no prior proposal or discussion about moving any current Region 4 team to another region, or moving any team from another region to Region 4.
- The Board's placement criteria involves only geography. School size and community demographics have not been placement criteria in prior discussions.
- It is the responsibility of the Commissioner to develop geographic alignment alternatives to present to the Board of Control for consideration and approval.
- The normal protocol would be to discuss options at their November meeting, with final determinations in January to allow for any necessary scheduling time for the future seasons.
- Where possible and given the appropriate number of teams, the alignments in the other non-classified team sports (baseball, soccer, softball and volleyball) normally mirror the basketball alignment.
- We will review a couple of possible alternatives at that meeting, but welcome input and suggestions as we try and accomplish the objective of preparing for the Board discussion.

We hope to see you at the Logan County CTC.
