RTA and its consultants have reviewed the Forms of Proposal from Bidders dated October 28, 2021 for Elizabethtown High School Restroom Renovations. This letter summarizes our evaluation of those forms of proposal and award recommendation.

The Form of Proposal documents submitted by bidders appear to be properly executed, having completed the Form of Proposal document, acknowledged receipt of addenda, completed the Base Bid -Lump Sum information, and signed the Limit for Execution form as well as bonding information.

All bidders have furnished alternate bid prices as well as the requested supplier/manufacturer and materials lists as needed.

The apparent low bidder is NPM, LLC from Elizabethtown, KY with a proposal of \$749,000 and an alternate added cost of \$200,000.
