#### HISTORY/BACKGROUND:

In the October Kenton County Board of Education meeting, the board approved a Memorandum Of Agreement (MOA) with the Commonwealth of Kentucky to partner with Kentucky Education Council for State Agency Children (KECSAC) to provide services to students at Northern Kentucky Youth Development Center (NKYDC). In this MOA, the calendar did not contain the correct number of extended instructional days as required by the Interagency Agreement between the Commonwealth of Kentucky and Kenton County School District.
