Consider / Approve the Revised BG-1 Construction Application for Ryland Elementary School.

**APPLICABLE BOARD POLICY:**

**HISTORY/BACKGROUND:**

The Kenton County School District approved a revised BG-1 application for a new addition and renovations at Ryland Elementary School during the regular Board Meeting held on December 7, 2020. The BG-1 Application was then further revised as a result of the actual bid award value and the contract award with Century Construction. It is now necessary to revise the BG-1 financial page to reflect the recent bond sale calculations. The revised financial page reflects a bond premium associated with the bond sale by virtue of the District's strong credit rating. This rating demonstrates the District's ability to stand on its own with an enhanced rating generating a very good net interest rate of 2.14%. The winning bidder provided a premium bid of \$449,683.00 instead of taking the customary discount of \$298,000.00. The net result of the sale is the District has reduced the amount borrowed by \$685,000.00 while still providing a cash contingency of \$72,754.00 to be divided among the four (4) projects (Beechgrove, Piner, Ryland, and White's Tower).
